### Most Important Symptoms and Effects, Both Acute and Delayed

#### Acute Symptoms and Effects:

Exposure to skin may result in redness, pain, burning, inflammation and tissue damage. Exposure to eyes may result in irritation, redness, pain, inflammation, itching, burning, tearing, corneal damage and loss of vision. 
